

Noel Sirabella passed away this past April while on vacation with his wife Sandy.



SAD #46 School Board meets monthly on the first Wednesday of the month at Ridge View Community School in Dexter. The district had six working committees: budget, facilities/ transportation, policy, student relations, curriculum and negotiations that met at various times of the year as well. The public is welcome to all meetings.

Exeter continues to hold 2 seats on the 13 person board: Kenneth (Kip) Dorman and myself, April Young. Kip Dorman continues to hold the seat on the AOS 94 Board. Both of us hold positions on various subcommittees on the board as well.

My three year term expires in March 2024. Hopefully I will get re-elected to serve the town for another 3 years. Kips's term expires in March 2025. Anyone wishing to run for the school board next year needs to have their paperwork in by January 2025 as the vote will be in March.

In 2023, we had several policies that needed updating and/or verbiage changed due to state requirements. The facility committee has met a few times throughout the year to discuss the progress on the Grade 9-16 Comprehensive School Project status. As of right now, the area schools are just waiting to get the Supplemental Budget information to cover the early project cost. Lastly, there are no concerns at this point with the '23-'24 school budget as revenue and expenditures are treading at the normal pace.

### **TOWN CLERK'S REPORT**

### 2023

I hereby submit the annual report for January 1, 2023 to December 31, 2023.

The following births, marriages, death and/or burial certificates have been recorded:

Certified copies of vital statistic records may be obtained at the town office for a fee of \$15.00 for the first copy and \$6 for each additional copy purchased at the same time. Proof of identification must be shown at the time of purchase to show relationship with the person listed on the record.

Dogs six months old and over must be registered. New dogs older than six months must be licensed within 10 days of ownership. Fees are \$6.00 per dog if they are spayed or neutered and \$11.00 if unaltered. Kennel licenses are \$42.00 for every 10 dogs. Dogs may be licensed starting October 15<sup>th</sup> and are due by December 31<sup>st</sup>. Dogs licensed after January 31<sup>st</sup> (one month grace period) will be charged a \$25.00 late fee per dog. You may license your dog online at www.10.informe.org/dog\_license/.

Registration fees for snowmobiles are now \$55.00 and ATVs are \$65.00 plus an agent fee. Agent fees are \$2.00 for new registrations and \$1.00 for renewals. Boat registrations are based on the length of the boat and the HSP of the motor.

New vehicle registrations for private sales are done until 3:30 p.m. Tuesday through Friday. For vehicles from the year 1998 to present, you must have the old title in hand when coming to register the new-to-you vehicle. Also, proof of valid insurance on the vehicle must be provided at time of registration. This year we registered and/or tended to 1,435 vehicles/trailers for the town of Exeter. If you would like to re-register your vehicle online, you may do so at SOSonline.org and select Rapid Renewal.

### Exeter Water Department---2023 Annual Report

Exeter's public water system met all State and Federal water quality standards in 2023.

The system continues to function properly.

-Water Production 660,000 gallons

-Water Sold 658,988 gallons

- -Nonrevenue Water (used at plant/flushing) 1,000 gallons (0.002%)
- -Accounted for Nonrevenue Water (used at plant/flushing) 1,000 gallons (0.002%)
- -Unaccounted for Water 12 gallons (0.0%)
- -Disinfection process consumed 137 liters (36.2 gallons) of 3% bleach---yielding an average chlorine residual of 0.66 mg/L (parts per million).
- -116 pump station inspections were performed.
- \*At year end we have eight (8) active public water customers and two seasonal.

The backup electrical power generator was serviced in 2023 and enables us to provide safe continuous drinking water during EMERA power outages.

The heat pump, which was installed in the pump station in year 2014, is providing efficient heating.

Note: Exeter is a member of Maine Rural Water Association. This association provides many valuable services to rural public water systems throughout the State of Maine.

In closing, I want to thank the Town Selectmen, Town Manager and Office Staff for their assistance.

#### Greetings,

The Exeter Historical Society made great strides in 2023. Along with making sure we were operating correctly as a non-profit, our outreach was impressive. We assisted with genealogy research for someone living in Germany and received item donations as far away as upstate New York. It is pleasing to have such an impact both inside and outside of Exeter.

We began our journey with an unofficial meeting in April. I wanted to see if there was enough public interest in reorganizing the group. There was a decent turnout so we continued on, meeting every month. In order to start operating

correctly we knew we needed to get our legal affairs in order. Our first step was to establish by-laws. This process took two long months to complete, but now our non-profit has set guidelines to operate by going forward. As we wrapped up the by-laws it was time to elect our officers and other board members. This vote by the members officially elected myself as President, Susan Wintle as Vice President and Secretary, Gayle Peirce as Treasurer, and Sara Brown and Petra Helbig as board members.

We ran our bottle drive from May until mid-September raising nearly \$1,400. These funds helped us pay for our 501(c)(3) application, obtain many needed supplies, and cases to start organizing and displaying our collection. Thank you to everyone who donated.

In the beginning of August, we established our place on Facebook by combining with a preexisting group and renamed it: Exeter, Maine Historical Society & Memories. This has given us a spot to post about our upcoming meetings, fundraisers, and share historical facts and photographs. The following week we submitted our 501(c)(3) application to the IRS, and in September we were notified that we were officially determined a federal tax exempt, non-profit organization with a public charity status. This determination will help us greatly when applying for grants. Shortly after that we were able to obtain a Maine Sales Tax Exemption and a confirmed charity status with PayPal.

In addition to all the legal preparations we began working on our 2024 calendars in August with financial support from our Exeter business sponsors. The last calendars produced by the Exeter Historical Society was nearly 20 years prior so we were excited to put together a new one. Photos were selected for every month and facts were gathered to add details and a story to each photograph. They went on sale to the public in November. We hope that everyone has been enjoying the calendars and if you'd like to purchase one, please let us know.

Just as we were starting the sale of the calendars, we were also wrapping up our first public display. It was ready for Election Day in the lobby of the town office. We included photographs, items, and written historical facts about an array of topics. Topics include the mills in East Exeter Village, the three Francis Hills of Exeter, the poetic contributions of David Barker, and the life of Louise (Cooley) Leathers. Again, we hope people are enjoying it, and we hope to do a fresh, new display in 2024.

We are looking forward to what 2024 will bring, and we welcome anyone who would like to join us in helping preserve Exeter's history. We meet at 6:30pm on the first Wednesday of the month in our room at the Exeter Town Office.

### Annual report 2023

Our library offers services to six communities: Dexter, Exeter, Garland, Ripley, Cambridge and St. Albans. Besides the usual loaning of books, magazines, audio books and movies the library also offers five public access computers, interlibrary loans, public color photocopying, and free scanning to an email address.

The library now offers two book clubs that each meet monthly. The non-fiction club meets on the last Wednesday of each month. The fiction club, which just began in November, meets on the second Wednesday of each month.

Story time is held on Friday mornings at 10 A.M. This is for preschool children and those home schooled up to the age of six. Saturday afternoon at 12:30 a UNO club meets; followed by a Lego challenge program for all ages at 1 P.M. Floral arrangement classes are held periodically, federal and state income tax assistance is offered from February through mid-April. Each year in early December a Christmas Tea featuring live music, holiday decorations and fantastic food is offered to the public. Other programs, both educational and recreational are held throughout the year. These programs are advertised on the library's website https://www2.abbott-library.com/ and it's Facebook page https://www.facebook.com/abbottmemorial

The library, although no longer hosting spay/neuter clinics, does still accept applications for spay/neuter assistance from the public and works closely with Spirits Place in St. Albans to see that each request is handled through various spay/neuter venues.

The library continues to add obituaries to its database. Obituaries from Dexter and Ripley are added weekly. The database is kept completely up-to-date.

#### Dear Friends:

It is an honor to serve the people of Maine in the U.S. Senate, and I welcome this opportunity to share an update on issues important to Maine and America.

One of my priorities for 2023 has been to improve the appropriations process in Congress – the way it decides how to spend taxpayer money. I took over as the Vice Chair of the Senate Appropriations Committee last year. Along with Chair Patty Murray, we decided the best change we could make was not to do something new. Instead, it was to do something old – that is, go back to the regular and transparent committee process that we used to have.

Part of restoring this process included holding 50 public Committee hearings, which allowed for input from senators on both sides of the aisle. As a result, for the first time in five years, the Senate Appropriations Committee passed all twelve of its funding bills on time. This was done with strong bipartisan support. In fact, seven of them passed unanimously.

Now, we need to work with the House of Representatives to pass these twelve bills and turn them into laws.

These bills contain funding for a wide range of Maine priorities, including support for the workforce at Bath Iron Works and Portsmouth Naval Shipyard, our lobster industry, infrastructure improvements, affordable housing, biomedical research, veterans, and heating assistance programs like LIHEAP. These bills also contain nearly \$590 million in Congressionally Directed Spending for 231 projects throughout the State of Maine. These projects would help promote job creation, expand access to health care, and improve public safety, infrastructure, and important resources in communities across all 16 counties of our state. I will continue to work to get these bills signed into law in the new year.

On October 25, the horrific mass shooting in Lewiston claimed the lives of 18 Mainers and injured 13 others. In response, I led Maine's Congressional Delegation in requesting an independent investigation by the U.S. Army Inspector General into the events leading up to the shooting. On December 15, the Under Secretary of the Army wrote to inform me that such an investigation will take place, and the Army Inspector General has instructed her team to immediately begin preparing to conduct this investigation. While nothing can undo the events of October 25, I will continue to work to understand what happened and what could have been done differently, and to find answers for the victims, survivors, and their families.

No one works harder than the people of Maine, and this year I honored that work ethic when I cast my 8,855th consecutive roll call vote.

As we look ahead to 2024, I remain committed to addressing the concerns of Maine families and communities. If you need assistance or wish to share your thoughts, please do not hesitate to reach out to one of my six state offices.

Dear Friends,

I hope this letter finds you safe and well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. I appreciate the opportunity to update you on what I've been working on behalf of the people of the Second Congressional District.

Maine's heritage industries are the backbone of our state's economy. That is why one of the first bills I introduced in this Congress was the Northeast Fisheries Heritage Protection Act, which would prohibit commercial offshore wind energy development in Lobster Management Area I (LMA 1) in the Gulf of Maine. LMA 1 was identified by the Bureau of Ocean Energy Management (BOEM) as a potential commercial offshore wind site. LMA 1 is a critical and highly productive fishing ground for a variety of sea life, including lobster. Prohibiting offshore wind development in LMA 1 would help to avoid conflict with the New England commercial and recreational fishing industries. Additionally, the bill would initiate a federal study on the environmental review processes of any relevant Federal agencies for offshore wind projects in the Gulf of Maine.

I also continue to advocate on behalf of our veterans and those providing care to our former service members. The current pay for VA employees in the Kennebec and Penobscot counties does not reflect the critical services they are providing. As the oldest state in the nation, with the fifth highest veteran population, Mainers rely on the services offered at the Department of Veterans Affairs (VA) facilities. That's why recently, Senator Collins, Senator King, Representative Pingree, and I called on the Biden Administration to increase locality pay for VA employees in Kennebec and Penobscot counties. The level of care received is impacted by job vacancies, and the high turnover rate among its healthcare workforce is often the result of pay and compensation issues, which is further exacerbated by the increased cost of living.

Lastly, I'm excited that Mainers are continuing to reap the benefits of the *Bipartisan Infrastructure Law* (BIL). Recently, millions of dollars in grants have been awarded across the state, including \$35 million through the U.S. Department of Transportation's Culvert Aquatic Organism Passage (AOP) program to conserve spawning and migratory habitats for native fish species in Maine, \$460,000 through the Airport Infrastructure Grant (AIG) program for the Princeton Municipal Airport, Stephen A. Bean Municipal Airport, and Dexter Regional Airport, and nearly \$8 million through the Buses and Bus Facilities Program for Bangor's bus system. These investments are critical to ensuring Maine's infrastructure and will help to ensure Mainers and businesses across Maine are connected.

Regardless of the year, one of my top priorities is ensuring I'm accessible to you. My staff and I can help answer questions about and navigate federal programs; find resources in Maine; and resolve issues with Medicare, Social Security, the VA, and other federal agencies and programs. I want to thank you for giving me the opportunity to serve you in the Maine Senate. It has been an honor to work on your behalf to make our state an even better place to live, work and conduct business. I am grateful you have put your trust in me, and I will continue to work tirelessly on behalf of the people of Senate District 4.

The First Regular and First Special Sessions of the 131<sup>st</sup> Maine State Legislature were notable as there were over 2,600 legislative bill requests and 2,019 of them were officially printed as Legislative Documents (LDs). No legislature this century has had as many LDs printed during its first year.

One area of success was in the Highway Fund. In the past, the Highway Fund has been supported through gasoline taxes, which have been declining for years due to more fuel-efficient and electric/hybrid vehicles, and bonding. However, we now have created a sustainable source of funding to maintain our transportation infrastructure. This is done by dedicating 40% of the vehicle sales tax and the sales and use taxes collected by the Bureau of Motor Vehicles. It is predicted to raise more than \$200 million for infrastructure each biennium.

I have heard from many of you regarding the biggest concerns you are facing, including the protection Maine's natural resources, increased costs of everyday items, access to health care and child care, education, housing, inflation, child welfare, mental health and substance abuse, workforce development, and crime, among others.
